The undersigned hereby acknowledges that (i) based on the good faith judgment of SportXcel, L.L.C. the undersigned has agreed to participate in a workout (the "Workout"), and to use the weight room, track, turf and other facilities (the "Facilities") at the SportXcel, LLC training center (the "Center"), and (ii) SportXcel, LLC has agreed to permit such participation by the undersigned on the terms and conditions hereof.

1. Assumption of Risk. The undersigned understands that there are risks of injury in connection with his use of the Facilities and his participation in the Workout (including, without limitation, the use of equipment, running, weight lifting, drills and fitness activities), and acknowledges that he/she voluntarily assumes and accepts those risks. The undersigned warrants and represents that his/her physical condition is sufficient for his/her use of the Facilities and participation in the Workout. The undersigned also represents and warrants that (i) he/she has procured adequate insurance coverage against medical expenses, disability, lost wages and other damages that might arise in connection with the Workout, (ii) such insurance coverage shall be primary for all circumstances in connection with the Workout, and (iii) the undersigned is not covered by, and shall make no claims under, any insurance policy of SportXcel, LLC, the Center or their affiliates in connection with the Workout at the Center.

2. Release.
